- 1. Short Cuts. Deck Lengths Less than 6'-0" require Field Cutting. By Others.
- 2. "Overhang Design per Deck Supplier" [19/S4.14]. E.o.R. to Specifiy Deck for Overhang condition.

3. " Deck Closure to Col Web per Deck Mfr." [2/S4.14]. Bid assumes deck is Cut to Fit.

GENERAL QUALIFICATIONS:

Project:

- Material payment in full Net 30 days no discounts or retention. Because Steel Encounters is a material supplier only, we will only accept a Purchase Order or Steel Encounters Signed Proposal. We will not accept a subcontract agreement. The summary, terms and conditions of this proposal, are not subject to change or deviation by purchasers; nor do we assume any responsibility or liability under contracts, agreements, or covenants between the purchaser and others. Contractual agreements shall not contain a clause that makes payment by Owner a condition precedent to Buyers obligation to make payment to Steel Encounters. NO PENALTIES, EXTENDED GENERAL CONDITIONS COSTS, OR LIQUIDATED DAMAGES OF ANY KIND WILL BE ACCEPTED, unless approved by Steel Encounters, Inc.
- Back Charges: In the event of field repair work which may incur back-charge costs to Steel Encounters,
 Steel Encounters must be notified at the time the problem is detected and be given the opportunity to review, verify and rectify the problem.
 If not, Steel Encounters will not be held liable for those charges.
 Said indemnification shall be limited to Steel Encounter's degree of fault in comparison to all others who may be at fault in whole or in part.
- 3. Steel Encounters reserves the right to pass on any sales tax rate adjustments which occur between the proposal date and the material delivery date.
- 4. If Steel Encounters Line of Credit (LOC) is used to pay for materials or labor prior to receiving contract payment.

Contract payments will be pledged as collateral to said LOC.

5. Steel Encounters is not an engineering firm. Steel Encounters will not generate any loads and is only responsible to include those loads clearly shown on the contract documents. The Engineer of Record (EOR) is responsible to provide Steel Encounters with all design criteria. Steel Encounters is only responsible to provide its joists and/or deck products per the design parameters provided by the EOR.

- 6. It shall be the Contractor's responsibility to receive and unload materials at the jobsite, to check for damage, and to verify that quantities delivered agree with carrier's bills and/or manufacturer's packing lists.
- 7. All material is furnished in accordance with (SDI) Steel Deck Institute specifications.
- 8. Submittal and field use drawings will NOT be stamped by an engineer per IBC #2207
- 9. Proposal does NOT include any Domestic or Recycled content requirement. (unless noted otherwise)
- 10. Due to the difficulty in obtaining field measurements in a timely manor, all deck at infills and minor openings will be supplied long for field cutting.
- 11. Concrete leak stop included in straight, 10 foot lengths.
- 12. Includes gauge metal slab edge forms per Table [K.1], in straight 10 foot lengths.

- 8. Deck sidelap punching tool. (Button Punch)

- 10. Deck at canopies or stair landings unless gauge and type is specified on the drawings.
- 11. Cleaning of deck or preparation prior to field painting.

12. Painting of Deck.

- 13. Galvanized deck is supplied passivated and may require cleaning prior to field painting. (materials and labor by others)
