Scope Notes:

This breakdown includes low voltage structured wiring internally within each individual residential unit as outlined on the below spreadsheet and proposal 14475-01 (01) Structured Wiring - 5/25/23. AVS wires run from device location as shown on plans (Tower A - Residential Sommet Blanc - 5/20/23) to low voltage sub panel(s) located within the unit. Our subpanel locations will require high voltage feeds and receptacles not included in our proposal. Any incoming service feeds or telecom wiring from main service panel (building headend) or between units is not provided by AVS and must be provided by the electricians.

Also included are a predetermined quantity of in-ceiling speakers for each individual unit in agreed upon areas within the unit. Speakers to be installed are shown on plans (Tower A - Residential Sommet Blanc - 5/20/23) as green or blue and will have brackets installed to hold their spot. Any other speakers shown on plans in yellow are prewire only and will be blind wired. Exact speaker models and locations are outlined on proposal 14475-02 (02) Speakers - 4/3/23.

A motorized shades package has also been provided for each residential unit as agreed upon. Shade Packages include the shades themselves along with corresponding components such as flap and hanger and power supplies as found on proposals. Shade details per unit can be referenced on the plans (Tower A - Residential Sommet Blanc - 5/20/23) or on proposal 14475-03 (03) Shades.

Lastly, each residential unit will be provided with x1 wall mounted removable iPad for control. iPad details and locations can be found on the plans (Tower A - Residential Sommet Blanc -5/20/23) or on proposal 14475-04 (04) iPad Wall Dock.

For the Amenity Areas we will also be providing low voltage structured wiring, and shades as outlined above. Details can be found on proposals 14478-01 (01) Structure Wiring also 14478-04 (04) Shades. Amenity Area plans can be referenced as (Building A - Amenity Areas Sommet Blanc - 5/24/23). In addition, for the Amenity Areas we will be providing a network package that is full gigabit speed compatible, WIFI 6 capable, and that we can also remotely monitor and reset if needed. This includes a firewall protected router that allows us to set priorities and multi-tasking, and true mesh network wireless access points. As outlined on proposal 14478-03 (03) Network 5/6/23. Finally we will be providing televisions and speakers along with all of the necessary components to power, drive and control them in the Amenity Areas AV proposal 14478-02 (02) Audio Video 5/17/23.
