Special Conditions:

- 1. Please note that we will need this signed proposal and ½ **down to start**, with the balance will be due once the glass is installed.
- 2. All hardware bid with CRL or Portals equivalent.
- 3. Once the order has been placed, with current lead times it will take approx. **4 to 6 weeks** from time of field measuring has been done. Field measuring has been included in our price.
- 4. Prices quoted above are valid if all items as noted in the proposal are all accepted as one contract. If these items are purchased separately the costs will need to be increased.
- 5. If changes are required to our scope of work by the General Contractor or by the owner it is Beehive Glass Co. policy not to proceed until we receive a signed change order that also accepts the price, we have bid.
- 6. Because of fluctuating market conditions all prices are good for **30 days only**. After which they may be subject to a price increase if the price of the glass or hardware increases.
- 7. We request that this Beehive Glass Company's Entire Proposal becomes a part of any subcontract or master agreement between Beehive Glass Company and the General Contractor.

Qualifications:

- 1. Clear glass has a greenish tint,
- 2. Low iron glass has a bluish / greenish tint
- 3. Tempered Glass: What is roll or roller wave distortion? The process of heating float glass to a level of soft pliability, then rapidly cooling it, will always cause optical distortion to some degree. This is the case for heat-strengthened and fully tempered glass. One common form of optical distortion is roller wave. During the heating process, glass will sag very slightly between the carrier rolls that transport the glass through the furnace. After heating, the glass passes through the quench, which "freezes" the glass, creating the compression and tension that provides either heat-strengthened or fully tempered glass. However, this process can also result in a slight deviation from optically flat glass, usually seen as ripples or roller wave. Glass thickness and size affect the amount of distortion: Generally, the thicker the glass, the less deviation from flatness, while larger glass sizes may also appear to have more distortion.

- 5. <u>Laminated Glass:</u> The tolerances are 1/16" to 1/4". The ASTM C1172-03 for rectangular shapes of glass. Because each piece of glass has to be cut, flat polished and tempered before being laminated, mismatched edges are a normal occurrence with laminated glass and are not a defect or a reason to reject the glass. The edge mismatch is generally most noticeable on the top of the glass and can easily be taken care of by the use of a top cap.

Bid Conditions

1.) Scaffolding:

Scaffolding, scissor lifts etc. to provide access to complete this job are **not** included in the price.

2.) Samples:

We will provide 2 ea. 8" x 8" samples of the specified glass listed in the inclusions. We will provide 1 ea. sample of the different types of metal hardware specified.

Samples free of charge, all other samples will need to be addressed as an additional charge item on a change order.

3.) Fabrication Time:

The fabrication time will depend on a number of things, including but not limited to:

- How soon fabrication drawings are available and released.
- The timely delivery of other needed materials.
- Timely reply to RFI's and change orders.

4.) Bond – no bond required.

If a Bond should be required it will need to be addressed as an additional charge item on a change order.

5.) Insurance:

We will carry and provide appropriate Liability and Workman's Compensation Insurance. No other Insurance is included in the prices bid. (Builders Risk Insurance is not included in the price and if required (and available) it will need to be addressed as an additional charge item on a change order.)

6.) Retainage:

No Retainage on orders that are ordered using a P.O. and on orders of materials only. Retainage to be no more than 5%. Retention is to be paid 30 days after completion of our scope of work, not the project completion. As per Utah law, the retention is to be held in an interest bearing account, with the interest being paid to Beehive Glass.

7.) Parking:

The cost of parking, on or offsite is not included in this bid and if paying for parking is necessary, it will need to be addressed as an additional charge on a change order.





8.) Specifically excluded from this bid is the following: It is not in the scope of our work to protect installed glass from damage by others. Should this become necessary, it will need to be addressed as an additional charge item on a change order.

- Labor is based on 40 hour work weeks. Overtime is not included and would need to be addressed as an additional charge item on a change order.
- Anything **not** specifically included is not part of this bid and will need to be addressed as an additional charge item on a change order.

9. Change Orders:

If changes are required to our scope of work by the General Contractor or by the owner it is Beehive Glass Co. policy not to proceed until we receive a signed change order that also accepts the price we have bid

- Glass Co. Inc., or Beehive Glass Co. Inc., has insecurity with respect to customer's creditworthiness, until payment is made and any dispute or insecurity has been resolved. Customer further agrees that Beehive Glass Co. Inc. shall not in any event be responsible for damages due to delay in supply of any labor or materials.
- Title to the above merchandise shall remain with Beehive Glass Co. Inc. or assigns until the sum due under this contract has been paid in full to Beehive Glass Co. Inc., Salt Lake City, Utah.
- The undersigned agrees that any amount not paid within 30 days of invoice date will carry interest and finance charges computed by a PERIODIC RATE of 1 1/2% per month, which is an ANNUAL PERCENTAGE RATE of 18% applied to the previous balance after deducting current payment and/or credits, both before and after judgment, and further agrees to pay all cost incurred in collections, including attorney's fees in the amount of 45% of the total balance due or a minimum of \$2,500.00, whichever is greater, if this account is placed with an attorney for collection, whether suit is filed or not.
