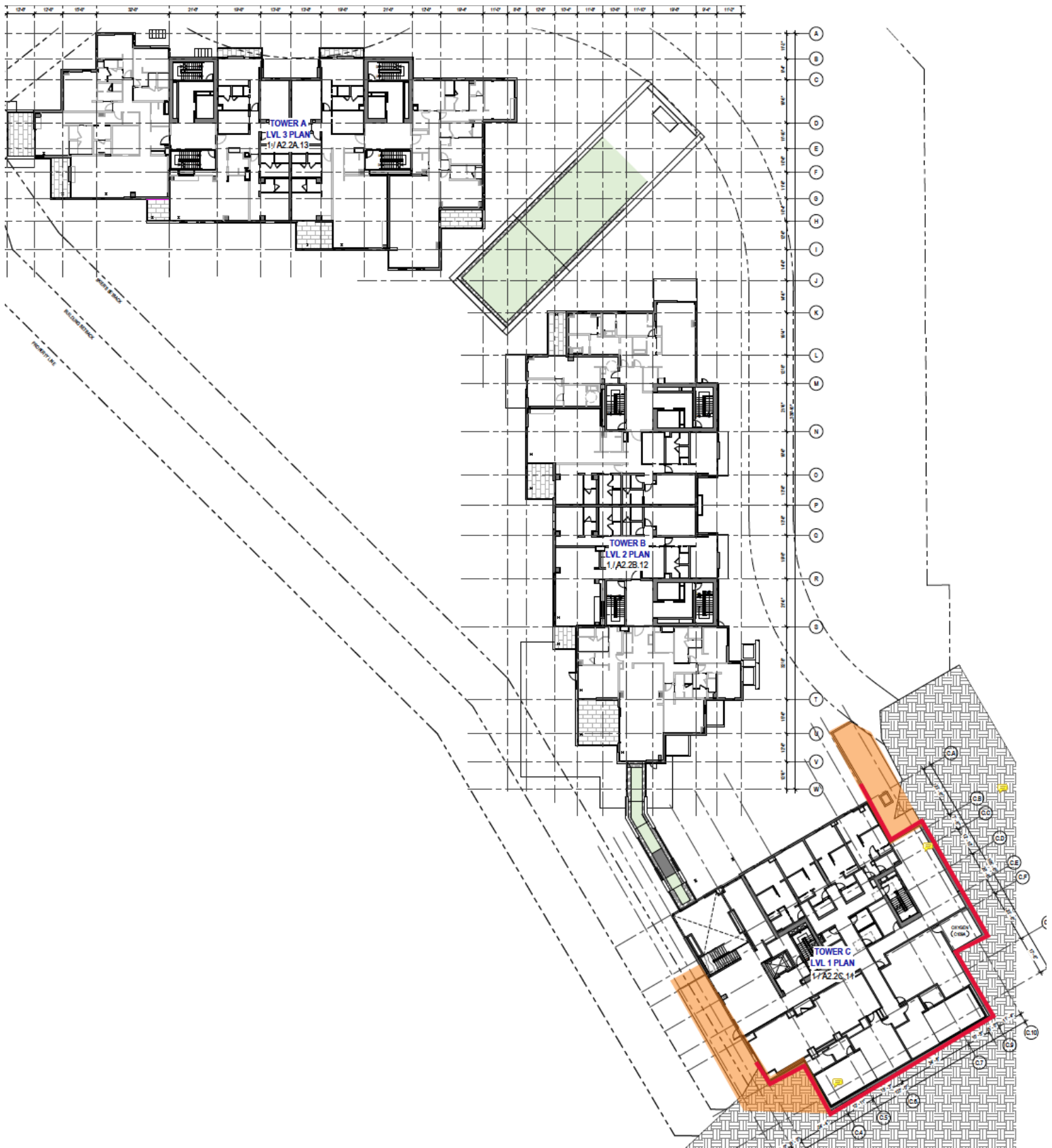












## WARRANTY SUMMARY

Warranty is void if you backfill before 24 hours or leave exposed more than 30 days. Warranty is also void if proper water management is not addressed such as working gutters, downspouts and proper grade with a minimum of 1/8" to 1/4" per ft. slope away from building. Complete warranty can be provided upon request.
