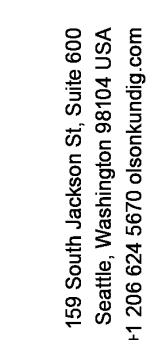
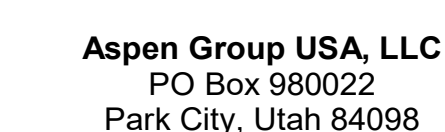

2. DIMENSIONS ARE TO CENTERLINE OF DEMISING WALLS. UNDO
3. ALL EXPOSED STRUCTURAL STEEL TO RECEIVE 1/2" CONCRETE PAINTING UNDO
4. AT TRAFFIC EXTERIOR WALLS, FRAMING TO BE SET BACK 5/8" FROM FACE OF CONCRETE TO ALLOW FOR FLANGE ALIGNMENT OF SEATING TO EDGE OF SLAB. UNDO
5. CASTERED WALLS TO BE SET BACK 1/2" FROM FACE OF CONCRETE. UNDO
6. SEE SHEETS 40 TO 46 AND 11 FOR ASSEMBLIES.
7. ALL CORNER WALLS ARE TYPE **JA**. UNDO
8. ALL DEMISING WALLS ARE TYPE **JE**. UNDO
9. ALL INTERIOR PARTITIONS ARE TYPE **JA**. UNDO
10. ALL PARTITION AROUND CORNERS ARE TYPE **JA**. UNDO
11. ALL REINFORCED CONCRETE COLUMNS TYPE **01**. UNDO
12. ALL REINFORCED CONCRETE WALLS TYPE **04**. UNDO
13. REFER TO LIFE SAFETY PLANS 40 TO 46 FOR FULL EXTENT OF FIRE RATED WALLS.
14. ALL PLAN LAYOUTS ON SHEETS 40 TO 46 ARE TO FACE OF WALLS.
15. ALL OWNER PARTITION WALLS SHALL INCLUDE E/F INFRASTRUCTURE.
16. REFER TO SHEET 40 FOR FLOOR AND TYPE A ACCESSIBILITY REQUIREMENTS.
17. REFER TO SHEET 40 FOR FLOOR AND TYPE B ACCESSIBILITY REQUIREMENTS.
